Griffith city serves a vibrant & growing "Food Bowl "region with approximately 63,000 population in our catchment. We are the largest winemaking region in NSW & second in Australia only to The Barossa Valley.

We are also the major growing district to nearly all Australia's rice, a hugely expanding Cotton industry, Citrus, Almonds, walnuts, hazelnuts, chicken, prunes & much more.

We are located 6 ½ hour's drive from Sydney & 5 hours from Melbourne.

One of the greatest challenges to businesses in our region is recruiting competent and qualified staff to fill the many job vacancies. Last year Griffith's unemployment figures were reported to be as low as 2.75% which is well below State & National averages.

Our community is so keen to try & attract new people to move to Griffith that Business, Council & State Government came together to fund over \$100,000 campaign Griffith Now Hiring. <u>http://www.griffithnowhiring.com.au/</u>

We believe that a "Zone A" special zone remote offset tax rebate should be applied as an income tax offset to people who work in Griffith & other growing regional centres.

Encouraging decentralization & putting people into jobs must a high priority for our State.

It is absolutely critical that the many vacant Griffith positions currently available in Health, Education, Emergency services & Local Government are prioritized to be filled.

We as a growing community have done all we can to encourage people to move to Griffith & fill these jobs, it is now time Our State Government build meaningful incentives to deliver the necessary outcomes our regional Community deserves.

Griffith Business Chamber strive for Griffith to Thrive & Grow. Griffith is the regional capital to the Western Riverina in South West NSW.

We are the largest winemaking region in NSW & second in Australia only to The Barossa Valley.

We are also the major growing district to nearly all Australia's rice, a hugely expanding Cotton industry, Citrus, Almonds, walnuts, hazelnuts, chicken, prunes & much more.

We are a resilient community with outstanding entrepreneurs investing heavily in job creating industries like the Casella family & Steggles Baiada group.

Despite the significant expansion in these industries & others our Gross Regional Product for Griffith LGA has been on a consistent decline since The Basin Plan began.

In 2010 our LGA GRP was \$1571 billion dropping each year to the current record low of \$1391 billion in 2016. Unfortunately this is even worse in the our neighbouring areas & towns in The Western Riverina. The MDBA interim Socio Economic report on the Southern Basin shows that HAY LOST 28.6 per cent of its irrigation water to the basin plan & TOTAL workforce declined from 1,624 to 1,221 (24.8 per cent) AGRICULTURAL workforce decreased 41.9 per cent. EMPLOYMENT in irrigated production decreased 41.4 per cent (over half between 2001 and 2006). Benerembah LOST 8.2% of available water 305.1GL.

TOTAL workforce declined 375 to 336(10.4%)

AGRICULTURAL WORKFORCE Decreased 21.5%

POPULATION Decreased from 516 to 493 persons (4.5%) between 2001 and 2016 Coleambally community LOST 7.9% of available water

TOTAL WORKFORCE DECREASED 21% Decreased from 514 to 406 FTE (21%) between 2001 and 2016

We know factors like commodity prices, machinisation, \$AUD & other influences are involved BUT NONE MORE than the stripping of Productive Water under The Basin Plan.

We look forward to making a public submission at the Griffith Hearing April 13th 2018.

A de-brief of the awards is to occur as a committee after the awards has concluded to provide feedback to NSWBC.

#### Speak up Campaign

Speak Up was established by a group of passionate farmers in the Southern Riverina as a voice for rural communities regarding the impact of water security. They are now seeking membership and support. Paul Pierotti suggested Gold membership of \$500. As a committee we agreed that this aligns with our 10 Point Plan regarding water security. #### **NSW Farmers**

Discussions between Paul Pierotti and NSW Famers have occurred regarding a joint relationship. This would open the avenue for both parties to access information, share knowledge. Each party to become a member of each organisation.

An Associate Membership of NSW Farmers is for those who have a general interest in the pastoral and agricultural industries but do not own a farm enterprise. Associate members include people who work in agricultural industries such as agronomists, students, teachers or people who own businesses in rural communities and to support NSW Farmers. (No Voting Entitlement) Cost for membership is is \$100. It entitles you to attend meetings and events but does not allow a vote. It will provide weekly information on the comings and goings in NSW Farmers and enable you to engage with members and our policy team.

Discussions were raised about the benefits and agreed to become an Associate member of NSW Famers and Amanda to seek membership of NSW Famers to Griffith Business Chamber.

Kirsty Parish attended the latest meeting for Grow Our Own. Since Grow our Own is growing, RDA Riverina presented a proposal to members to employ a person as a Grow Our Own project officer. A budget of \$45,000 was prepared and RDA are seeking support from partners to assist funding this position.

The question was asked what would GBC be willing to contribute to this project for 12 months. Paul gave some history about Grow our Own and feels there needs to be more discussion, there appears to be a disconnect with Griffith County University Centre at this stage.

We are currently experiencing an agricultural boom and need to ensure this continues and the economy lifts in this area.

### 6.11 10 Point Plan

In January 2018 the 10 Point Plan was updated and reviewed to reflect the member survey results. Many suggestions were put forward by the committee, reworded several times and resulted in a majority decision on the new 10 Point plan. The 10 Point Plan continues to be Chambers goals, focus and purpose.

### 6.12 Basin Plan Strategy

Paul Pierotti and Katie Lucantonio met with Susan Ley in February 2018 and presented the following points in length.

This is Griffith Business Chamber's position on the Basin Plan.

• Place a 5 to 10 year moratorium of no further productive water acquisition. This will allow the MDBA and CEWO the time to use this period to prove the benefits that can be gained with what is already in the environmental bucket before another any more productive water acquired

• Use this interim period to assess exactly what volumes CAN actually be delivered.

• Fully support Vic and NSW stance and Blair pulling out of Basin Plan & thank Federal Member for Farrer Sussan Ley & NSW Murray Member Austin Evans for supporting NSW withdrawal.

• Royal Commission focussing on 31 Federal Senate Inquiry recommendations.

The opportunity for Griffith to Melbourne flights is so important for the local business and tourism industry. The benefits would open fantastic opportunities for all. Griffith Business Chamber continue to explore opportunities and are in serious discussions with a very meaningful public passenger aircraft provider.
