6.3: MIA Communities Sub Committee recap

Paul and Amanda gave a brief overview of the work conducted so far by the committee. Membership of farmers is difficult at the moment because of COVID and they are constantly being asked to join or pay a levy from every type of industry group. To ease the pressure on farmers and to gain support in numbers the sub committee has brought to the Chamber Executive a solution to overcome this hurdle.
