5.1 Business Awards 2023

5.2 Employment Expo 2023

Around 25 businesses have secured a spot. Coasting along nicely. Finally got hold of venue to confirm. Need to follow up.

5.3 Small Business Month

Funding criteria was released this week. Eligible for \$3,500. Event must be held in October 2023.
